PROMOTION DESCRIPTION

Megalink[®] Service

OVERVIEW OF PROMOTION:

In accordance with the special promotions section of the Private Line Services Tariff, BellSouth plans the following MegaLink Service promotion for small business subscribers that will begin on September 1, 2005, and end on December 31, 2005. For qualifying subscribers who sign a twenty-four (24) month or longer agreement for a MegaLink point-to-point circuit, this promotion offers a waiver of the nonrecurring charges for the digital local channel and interoffice channel. For qualifying subscribers who sign a thirty-six (36) month or longer agreement for a MegaLink point-to-point circuit, this promotion offers a waiver of the nonrecurring charges for the digital local channel and interoffice channel in addition to a credit for the mileage sensitive digital local channel and interoffice channel.

PROMOTION SPECIFICS:
