EXECUTIVE SUMMARY

Description of Proposed Tariff

The purpose of this General Subscriber Services Tariff and Private Line Services Tariff filing is to modify the existing rules and regulations governing the redemption procedure for the BellSouth President's Reward. The BellSouth President's Reward is an existing bonus reward offer available to qualifying BellSouth Select Business Program participants.

Currently, if a Program Participant has not redeemed the BellSouth Select President's Reward(s) and fails to provide notice of the redemption option selected by the end of the calendar quarter immediately following the quarter in which the benefit is earned, the benefit is redeemed on behalf of the customer for one of the existing President's Reward options. This rule modification was established on March 15, 2005.

BellSouth plans to return to the original rules governing the redemption of this additional bonus reward. Effective March 13, 2006, the additional bonus reward will be forfeited if the Program Participant fails to provide notice of the selected redemption option by the end of the calendar quarter immediately following the quarter in which the benefit is earned.

The proposed effective date of this filing is March 13, 2006.
