## Promotion Description

### Florida Migration Credits and Waiver

Beginning September 24, 2007, residential local exchange customers of AT&T Communications of the Southern States, LLC and AT&T Communications of the South Central States, LLC (AT&T Communications) will be notified that they will be bulk transferred, in accordance with applicable state Commission and Federal Communications Commission (FCC) requirements, to BellSouth Telecommunications, Inc, d/b/a AT&T Southeast. From September 24, 2007 through December 31, 2007, customers who opt out of the bulk transfer process and request that their service be switched to AT&T SE will receive a waiver of the line connection charge (first and additional lines). Customers who are bulk transferred will not incur service connection charges.

Beginning November 12, 2007, residential customers who are transferred from AT&T Communications to AT&T SE will be eligible to receive the following service plan and feature credits. The service plans and feature credits will be available under the following conditions:

- Customers are bulked migrated in accordance with the Federal Communications Commission's (FCC) bulk migration rules 47 CFR § 64.1120(e) and any applicable state bulk migration rules and,
- The customer's new AT&T SE local service plans and/or features rates would exceed their existing AT&T Communications rates.
