Overview

The Business Shoppers Reward promotion is scheduled to begin on 05/01/2008 and end on 08/31/2008. This promotion is an offer available to new (acquisition/reacquisition) AT&T business subscribers located in the AT&T Southeast region. The Business Shoppers Reward Promotion will offer subscribers a one-time non-recurring \$100.00 coupon redeemable for a debit card. To be eligible for the coupon, the subscribers who contact or are contacted by AT&T must request information on local exchange service for comparison with competitive offers, or otherwise if necessary for the customer to agree to purchase a Complete Choice for Business Line package and sign a local service term agreement from AT&T.

Promotion Specifics

This promotion is an offer available to new (acquisition/reacquisition) AT&T business subscribers located in the AT&T Southeast region. The Business Shoppers Reward Promotion will offer subscribers a one-time non-recurring \$100.00 coupon redeemable for a debit card.
