Encore Bonus Promotion

Overview

The Encore Bonus Promotion is scheduled to begin on 01/01/2009 and end on 08/31/2009.

This promotion is an offer available to existing AT&T business subscribers located in the AT&T nine (9) state SE region, excluding certain wire centers in Florida, with 120 days or less remaining on their current AT&T local service subscriber term Agreement. To be eligible for this promotion, Subscribers who contact or are contacted by AT&T must request information on local exchange service for comparison with competitive offers, or otherwise if necessary for the customer to agree to purchase a new AT&T local exchange service term agreement. A qualifying Subscriber will receive a one-time credit of \$100 for signing a new AT&T local exchange service agreement within the 120 day period.

Promotion Specifics
