### **Remote Call Forwarding (RCF) Promotion**

#### **Overview**

The Remote Call Forwarding (RCF) Promotion is scheduled to begin on 01/01/2009 and end on 8/31/2009. The RCF Promotion (the "Program") will offer discounts on the Subscriber's bill. The offer is only available to new AT&T subscribers requiring RCF to maintain their local exchange business number(s) or existing AT&T subscribers who are moving within their local area and are required to change their business telephone number(s).

#### **Promotion Specifics**

Qualified business customers will receive the fixed monthly portion of RCF service for the equivalent of \$5.00 per month per RCF feature arranged for a maximum period of twelve (12) months. The Subscriber will be billed the current applicable fixed monthly RCF rate (e.g. as specified in AT&T's lawfully filed tariffs or otherwise provided in AT&T's Price List) and provided monthly bill credits calculated to provide for an equivalent RCF fixed monthly rate of \$5.00. Any normally applicable usage charges associated with RCF will be applied and will not be subject to a discount. The discount will appear as a credit in the Rewards and Discounts section of the Subscriber's bill in either the current or a subsequent billing period usually within one or two billing cycles.
