Centrex Thank You for Renewing

Overview

The Centrex Thank You for Renewing promotion is scheduled to begin on 1/1/2009 to 4/30/2009. The promotion provides a credit of \$50 per station up to a maximum of 30 stations or \$1500 for a 36 month term agreement. The goal of this program is to increase retention of Centrex and increase their term commitment.

Promotion Specifics

This promotion applies to existing and expired tariff term agreements for Centrex, Centrex Service Package, and AT&T Centrex Re-Term Promotion customers.
