2. Explanation of Terms (Cont'd)

SUBSCRIBERS IN GENERAL - as used in this tariff, is to be interpreted to include those cases where *the* construction *of permanent facilities* is required to serve two or more customers.

TEMPORARY FACILITIES - facilities used to provide service(s) where it is known before construction that the facilities will be relocated, abandoned or removed prior to the normal service life of the facilities. The cost of temporary facilities is not to be recovered from subscribers in general and does not constitute a carrier of last resort obligation for the Company.

TERMINATION CHARGE - the portion of the maximum termination charge that is applied as a nonrecurring charge when all services are discontinued prior to the expiration of the specified liability period.

UNDERUTILIZATION CHARGE - an obligation, incurred by a customer, which is designed to reimburse the Company for the annual costs of a portion of specially constructed facilities when the customer's actual use of those facilities is less than 70% of the amount of use forecasted or ordered by the customer.

Special construction consists of a series of tariff regulations that are designed to protect the Company from undue risk associated with specially constructed facilities and allows the Company to recover excessive investments incurred by the construction of facilities that will carry services currently offered on a general basis in a service

TEMPORARY FACILITIES - facilities used to provide service(s) to a customer where it is known before construction installation of the newly placed facility that the facilities will be relocated, abandoned or removed prior to the normal service life of the plant facilities. The cost of temporary facilities is not to be recovered from subscribers in general and does not constitute a carrier of last resort obligation for the Company.

TERMINATION CHARGE - the portion of the maximum termination charge that is applied as a nonrecurring charge when all services are discontinued prior to the expiration of the specified liability period.

UNDERUTILIZATION CHARGE - an obligation, incurred by a customer, which is designed to reimburse the Company for the annual costs of a portion of specially constructed facilities when the customer's actual use of those facilities is less than 70% of the amount of use forecasted or ordered by the customer.

The term "customer" as used in the preceding context also includes those entities_/businesses, government agencies or their agents, which, request the construction of temporary facilities or due to the nature of their business operations, may create a requirement for the construction of temporary network facilities. to terminate a concentration of network facilities at said entities' operational centers. Such facilities The services provided over the temporary facilities may be individually ordered by and billed to separate end user customers. who are patrons of the entities and typically utilize the facilities to avail themselves of the entities' services. Examples of such entities or businesses include, but are not limited to, Telephone Answering Services, Specialized Mobile Radio Systems, and Radio Common Carriers, political campaigns, sporting events, concerts, and government agencies such as the Federal Emergency Management Agency (FEMA).
 - h. No customer shall be charged special construction rates for the minimum grade of line offered where the new plant parallels and reinforces existing plant or is constructed on or along any public road or highway and is to be used to serve subscribers in general.
