## **EXECUTIVE SUMMARY**

### **Introduction**

The BellSouth Centrex Simultaneous Ring (“SimRing”) Virtual Directory Number (VDN) optional feature enhancement service enables a Ringmaster Directory Number to have SimRing capabilities. A Virtual Directory Number is a directory number that exists solely in software with no physical line appearance or hardware associated with it.

The Centrex SimRing VDN enhancement allows SimRing customers to utilize the RingMaster/Teen Service feature while permitting each RingMaster/Teen Service number to have separate SimRing groups. The SimRing VDN feature will allow a VDN to be used as the Pilot Directory Number for a SimRing group.

The primary application for this feature is a college/university dorm service BellSouth Centrex offer. As part of this offer, the integration of the customer’s voice mail service, whether CPE or network based, with this feature will be key to its success. Students will be able to change dorm rooms and take their number with them and will have a personal voice mail box to which their calls forward.

This feature will only be provided for BellSouth Centrex Service and is not available for ESSX or MultiServ customers even by Special Assembly.

### **Description of Proposed Tariff**

BellSouth Centrex SimRing Virtual Directory Number will be an enhancement within the BellSouth Centrex SimRing section. It will be added to the existing BellSouth Centrex tariff optional features (A12.25.12).

BellSouth new SimRing enhancement will cover its costs.
