#### **T-Order Closer Waiver**

#### Overview

The T-Order Closer Waiver promotion is scheduled to begin on November 13, 2006 and end on April 27, 2007. Existing residential customers who place an order to move their service to a new location through a Consumer Inbound sales channel may be eligible for a waiver of the line connection charge.
