# Overview

The BellSouth Line Connection Waiver Promotion is scheduled to begin on January 1, 2007 and end on August 31, 2007. This promotion is available to BellSouth business customers with a new location who currently have local exchange service with another local exchange provider. Subscribers who participate in the Program and subscribe to service at a new location will not be billed for line connection charges and change in service charges, if applicable, associated with the service order.

### **Promotion Specifics**

The promotion is offered to BellSouth business customers with a new location and who currently have local exchange service with another local exchange provider. Customers who subscribe to service at a new location will not be billed for the line connection charges and change in service charges, if applicable, associated with the service order. This will include the Line Connection Charge (first and additional lines, line equivalents, and trunks) and the charge for change in service, if applicable.
