Overview

In accordance with the special promotions section of the General Subscriber Services Tariff and/or the General Exchange Price List, The BellSouth Simply 30(sm) Promotion is scheduled to begin on 01/01/2007 and end on 08/31/2007. This promotion ("Program") is an offering available to new BellSouth business customers in the BellSouth region who currently have local exchange service with another local exchange provider.
