Overview

The Centrex Thank You for Renewing promotion is scheduled to begin on 09/01/2007 and end on 12/31/2007. The promotion provides a credit of \$35 per Centrex line with a maximum credit of \$1225 (35 lines) for a tariff term customer who renews their Centrex Contract for 36 months or greater. This promotion applies to tariff term customers only. The goal of this program is to increase retention of Centrex and increase their term commitment.

Promotion Specifics
