EXECUTIVE SUMMARY

Description of Proposed Tariff

This General Subscriber Services Tariff filing provides for an increase in the trouble location charge for exchange and WATS service. This charge is applied per service call in response to a customer trouble report when it is determined that the trouble originated from a source on the customer's side of the demarcation point.

This filing increases the Miscellaneous Non-Basic Services basket by 0.52 %, which is within the allowed limits for this basket.
