#### **Overview**

A \$50 Saves Closer Coupon would be available for SAs to use when existing residential customers contact BellSouth to disconnect service in attempt to prevent the customer from disconnecting their local service. Customer must retain Complete Choice or Area Plus with Complete Choice feature package.
