EXECUTIVE SUMMARY

Description of Proposed Tariff

This General Subscriber Services Tariff filing increases the rates for Non-Published and Non-Listed Directory Listings for residence and business.

Revenue Impact

This filing results in an increase in the Directory Assistance Non-Basic Services basket in the amount of 7.29%, which is within the allowed change for this basket.
