## **Promotion Description**

#### AT&T Bundle Trio Month Reward Promotion

#### Overview

The AT&T Bundle Trio Month Reward Promotion is scheduled to begin on 09/02/2008 and end on 12/31/2008. This promotion is available to new AT&T business line Subscribers who bring a minimum of one business access line to AT&T from another local provider subscribing to a Complete Choice for Business (CCB) package, an eligible long distance calling plan and an eligible FastAccess Business DSL plan. The AT&T Bundle Trio Month Reward promotion will provide a bill credit equal to the Subscriber's eligible monthly charges for the CCB package, long distance plan and for FastAccess Business DSL plan for three (3) consecutive billing periods. The bill credit will appear in the first three (3) bill periods from the beginning of participation in the promotion.
