Select Complete Choice for Business Bonus

Overview

The Select Complete Choice for Business Bonus promotion is scheduled to begin on January 1, 2009 and end on December 31, 2009. Select customers who purchase a new Complete Choice for Business package during the promotional timeframe will earn AT&T Select Business Rewards bonus points.

Promotion Specifics

Program Eligibility:

- Available to existing and new AT&T Select Business Rewards customers. New AT&T Select customers must meet AT&T eligibility requirements – between \$100 and \$3,500 in AT&T eligible spending per month.
- Any new or existing AT&T Select customer that meets all eligibility requirements during the promotional period will be eligible for the rewards.

Program Elements:

- AT&T Select members who purchase a new Complete Choice for Business package will receive a bonus reward of 1,000 AT&T Select points.
- If the customer keeps the Complete Choice for Business package for a continuous 90-day period, the customer will receive an additional bonus reward of 2,000 AT&T Select points.
