AT&T Business Line Connection Waiver Promotion

Overview

The AT&T Business Line Connection Waiver Promotion is scheduled to begin on January 1, 2009 and end on December 31, 2009. This promotion is available to AT&T business customers with a new location who currently have local exchange service with another local exchange provider. Subscribers who participate in the Program and subscribe to service at a new location will not be billed for line connection charges and change in service charges, if applicable, associated with the service order.
