This filing grandfathers the residence bundle, Standard Home Phone II. In addition, this filing revises the Standard Home Phone II eligibility requirements to relax the requirement to maintain a long distance plan. Although customers were required to subscribe to a long distance plan initially, if they drop the long distance plan later, they have not broken the bundle requirements and can continue to subscribe to the service.

All existing customers subscribed to this service have Voicemail. The criteria are changing to reduce the number of required options. Since customers already subscribe to Voicemail, there are no increases. Also, Data LineGuard and LineGuard were merged into one product name, LineGuard.
