## JOINT MOTION OF THE OFFICE OF PUBLIC COUNSEL AND THE INDUSTRIAL INTERVENORS FOR AN EXTENSION OF TIME TO FILE TESTIMONY

- 3. So that the opportunity of the movants and other parties to respond to this testimony is not impaired, Public Counsel and the Industrial Intervenors further request a corresponding short extension of the time for rebuttal to this cost of service/rate

design testimony. Rebuttal is now due on Nay 15. Public Counsel and the Industrial Intervenors request an extension to May 21.

- 4. These brief extensions will not prejudice any party or affect the hearing schedule in this case.
- 5. The undersigned are authorized to represent that neither Gulf Power Company or Staff objects to this motion. The undersigned have been unable to contact the attorney for the Federal Executive Agencies of the United States.

WHEREFORE, Public Counsel and the Industrial Intervenors request that the Commission enter an order extending the filing date for the cost of service rate design testimony of Mr. Wright and Mr. Pollock to May 2 and the deadline for rebuttal to this testimony to May 21.
