NOTICE OF PROPOSED AGENCY ACTION ORDER APPROVING RATE SCHEDULE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are adversely affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

On March 6, 1990, Palm Beach County Utilities Corporation filed an application for approval of new Tariff Rate Schedule "SL" for commercial street lighting.

As indicated by Palm Beach County Utilities Corporation's application, every project or development that utilizes natural gas street lighting will have one gas light metered. The Company will bill each project based on the meter reading times the number of lights in that particular project, plus a \$10.00 customer charge one time per month per project or development.

Until the Company has experienced actual data dealing with natural gas street lighting, the development of the SL rate represents the Company's best guess, as shown in Attachment A.

For lighting, electricity is more efficient than gas. In the past provisions of PURPA recognized this and, in fact, outlawed gas lighting. Those portions or PURPA have been done away with. This tariff recognizes that some customers now want the choice of gas lighting for aesthetic reasons. In approving this tariff, we are recommending that customers should use gas lighting or inferring that outdoor lighting is an efficient use of gas. We approve the tariff so that ratepayers may have the service they want. Market forces should then drive customers' decisions.

Accordingly, we approve Palm Beach County Utilities Corporation's "SL" Rate Schedule until such time as the Company's next rate case, when a commercial street lighting rate will be developed based on actual cost to serve.

In consideration of the foregoing it is

ORDERED by the Florida Public Service Commission that Palm Beach County Utilities Corporation's "SL" Rate Schedule is hereby approved.

Any person whose substantial interests are affected by the action proposed by this order may file a petition for a formal proceeding, as provided by Rule 25-22.029(4), Florida Administrative Code, in the form provided by Rule 25-22.036(7)(a) and (f), Florida Administrative Code. This petition must be received by the Director, Division of Records and Reporting at his office at 101 East Gaines Street, Tallahassee, Florida 32399-0870, by the close of business on May 30, 1990

In the absence of such a petition, this order shall become effective on the day subsequent to the above date as provided by Rule 25-22.029(6), Florida Administrative Code, and as reflected in a subsequent order.

Any objection or protest filed in this docket before the issuance date of this order is considered abandoned unless it satisfies the foregoing conditions and is renewed within the specified protest period.

If this order becomes final and effective on the date described above, any party adversely affected may request judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or by the First District Court of Appeal in the case of a water or sewer utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days of the effective date of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
