Southern States Utilities, Inc. (SSUI) provides water and wastewater services in twenty-four counties in Florida and owns or operates around 140 water and wastewater systems of various sizes and types serving thousands of customers. The annual report for 1989 indicates that the consolidated annual operating revenue for the intrastate system is \$4,638,000 and net operating income is \$903,000. The utility is a Class A utility company under FPSC jurisdiction.

On January 10, 1991, the utility applied for an amendment to it's Wastewater Certificate No. 156-S in Citrus County, Florida. The proposed territory is located off U.S. Highway 41 and North Citrus Springs Boulevard in Citrus County. The proposed territory is zoned for light commercial usage and containing 40 lots.

AFA The application is in compliance with the governing statute, Section 367.045, Florida Statutes, and other pertinent statutes and administrative rules concerning an application for amendment of CAF certificate. The application contains a check in the amount of CMU. \$150.00 which is the correct filing fee pursuant to Rule 25-30.020, Florida Administrative Code. The applicant has provided evidence CTR that the utility owns the land upon which the utility's facilities EAG are located as required by Rule 25-30.036(1)(d), Florida Administrative Code. LEG

Adequate service territory and system maps and a territory description have been provided as prescribed by Rule 25-30.036(1)(e),(f) and (i), Florida Administrative Code. A description of the territory requested by the utility is appended to this memorandum as Attachment A. The utility has submitted an affidavit consistent with Section 367.045(2)(d), Florida Statutes, that it has tariffs and annual reports on file with the Commission.

In addition, the application contains proof of compliance with the noticing provisions set forth in Rule 25-30.030, Florida Administrative Code. No objections to the notice of application have been received and the time for filing such has expired.

Presently, SSUI provides quality sewer service to the residents of Citrus County. The utility has the capability and financial resources to adequately service the proposed new territory. The 40 additional lots will have no substantial effect on the utility's financial status. SSUI currently has no outstanding violation reported by the Department of Environmental Regulation in regards to it's Citrus Springs plant as of their 1989 review.

Based on the above information, staff believes it is in the public interest to grant the application of SSUI for amendment of it's Sewer Certificate No. 156-S for the territory described in Attachment A. An administrative order should be issued approving the application.

The utility's approved rates and charges were effective January 18, 1991, pursuant to a 1990 price index pass through. The utility has indicated that the proposed amendment will have no significant impact on its existing rates and charges. Staff recommends that these rates and charges be applied to customers in the new service territory.

The utility has filed revised tariff sheets incorporating the additional territory into its tariff and returned its certificate for entry reflecting the additional territory.
