Notice is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for formal proceeding pursuant to Rule 25-22.029, Florida Administrative Code.

Murdock, Remmers & Associates, Inc. filed an application for an interexchange certificate on January 21, 1991. The application contained the required background information and its proposed tariff. After having considered the application, it appears that the Company is technically capable of providing service.
