In response to the initiation of this proceeding, 2001 filed a stipulated offer of settlement. The terms of the settlement are as follows:

- 1. 2001 shall pay a fine of \$250.
- 2001 shall file an annual report for 1990.
- This docket shall be closed by staff upon receipt of the fine and the annual report.

In view of 2001's stipulated admission of failure to file a 1990 annual report, we find it to be in the public interest to accept 2001's offer of settlement.

Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court.
