- (5) Provide a statement as to why the purchase of Aqua Pure Water Company and A.P. Utilities were concluded without prior Commission approval.

- (1) As we discussed, there is a question as to the purchase price of the Marico System. Please clarify what you believe the price to be and why Mr. Blake is quoting another figure.
- (2) Provide a recorded copy of the lease for the plant site as well as documentation that you have assumed the lease.
- (3) You will not need to renotice the four mile list. However, you must provide a notarized affidavit that such noticing was done. With this affidavit attach a list of the entities noticed. You still need to properly notice the individual customers and provide me a copy of the notice and corresponding notarized affidavit. Additionally, you must provide proof of your newspaper noticing.
- (4) Your financial statement and a financial analysis showing your ability to operate A.P. Utilities.
- (5) Provide a statement that you will fulfill the commitments, obligations and representations of the prior owner. Additionally, provide additional detail as to your or your contract operator's experience in the utility business.
- (6) Provide a statement as to why the purchase of the Marico system was concluded without prior Commission approval.
- (7) Pursuant to our discussion you were going to discuss with Mr. Blake the voluntary refund of the \$2100 of CIAC which was illegally collected. A completed refund prior to taking this Docket to the agenda would eliminate consideration of this matter as a legal issue.
