REQUEST FOR CONFIDENTIAL CLASSIFICATION AND MOTION FOR PERMANENT PROTECTIVE ORDER

Comes now GTE Florida Incorporated ("GTEFL" or "Company"), pursuant to the provisions of Commission Rule 25-22.006, and seeks confidential classification and a permanent protective order regarding certain interLATA traffic information owned by AT&T Communications of the Southern States, Inc. ("AT&T") which is responsive to Commission Order No. 24718 issued on June 26, 1991. In support of its request, GTEFL respectfully states as follows:

1. On June 26, 1991, the Commission directed GTEFL to submit traffic studies pertaining to this request which contain in part interLATA traffic information which belongs to AT&T. This information constitutes proprietary and confidential business information.
