2 25-4.150 - THE ADMINISTRATOR

3 (1) The Administrator is a corporation not for profit
4 incorporated pursuant to the provisions of Chapter 617, F.S., and
5 designated by the Florida Public Service Commission to administer
6 the telecommunications relay service system and the distribution of
7 specialized telecommunications devices pursuant to the provisions
8 of Part III of Chapter 427, F.S., and rules and regulations adopted
9 by the Commission.

10 (2) For the purposes of implementing Part III of Chapter 427,
11 F.S., the Florida Telecommunications Relay, Inc. is designated as
12 the Administrator identified in Chapter 427.704(2). The
13 Administrator's offices are located at 1311 N. Paul Russell Road,
14 Suite 203-B, Tallahassee, FL 32301-4860, telephone number (904)
15 656-1414.

16 (3) The Administrator will be responsible for receiving and
17 distributing funds from the operating fund. The Administrator will
18 expend no funds from the operating fund to be used to pay for the
19 cost of the Advisory Committee. The Administrator will expend no
20 funds from the operating fund to be used to pay for entertainment.
