Item No. 45 (Docket No. 910056-PU) is the complaint of consumer John Falls regarding resale of electricity and gas by the H. Geller Management Company. In this docket, staff has recommended that the condominium owners at Terrace Park of Five Towns be reimbursed \$77,149.25 by the Geller Company. Since filing its recommendation however, staff has realized that its computation of the \$77,149.25 figure was in error.

This error occurred when staff relied on information supplied by Florida Power Corporation to explain discrepancies between the bills paid by Geller Corporation and the bills calculated by staff based on tariffs. This information has been found to be in error. In order to determine the basis for the discrepancy, individual bills for common area meters must be audited for each month in question, which was not done during the original audit. Therefore, staff would request that Item 45 be deferred so that staff can complete its audit and correct its error.
