BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are adversely affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

On January 17, 1992, MCI Communications Corporation (MCIC), SouthernNet, Inc., and SouthernNet Systems, Inc. filed a Petition requesting the Commission to acknowledge a change in corporate According to the Petition, MCIC will continue to structure. exercise indirect majority organizational control over operations as approved by Order No. 23052. The change involves neither a transfer of the certificate of public convenience and necessity, nor transfer of majority organizational control of the certificate. The restructuring will simply eliminate a layer of corporate structure between the SouthernNet Companies and MCIC, their ultimate parent.

Upon review, we acknowledge the corporate restructuring.

In the absence of such a petition, this order shall become effective on the day subsequent to the above date as provided by Rule 25-22.029(6), Florida Administrative Code.

Any objection or protest filed in this docket before the issuance date of this order is considered abandoned unless it satisfies the foregoing conditions and is renewed within the specified protest period.

If this order becomes final and effective on the date described above, any party adversely affected may request judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or by the First District Court of Appeal in the case of a water or wastewater utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court.
