3. If Public Counsel subsequently notifies Southern Bell that this proprietary information is to be used in a proceeding before the Commission, Southern Bell will, in accordance with Rule 25-22.006 Florida Administrative Code, file a detailed Motion for Protective Order specifically addressing the information identified.
