Notice is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for formal proceeding pursuant to Rule 25-22.029, Florida Administrative Code.

Triax Telecom, Inc. filed an application for an interexchange certificate on April 10, 1992. The application contained the required background information and its proposed tariff. After having considered the application, it appears that the Company is technically capable of providing service. Therefore, we find that it is in the public interest to grant a certificate to Triax Telecom, Inc., and it is our intention to grant the certificate. Interexchange carriers (IXCs) are subject to the provisions of Rules 25-24.455 through 25-24.495, Florida Administrative Code. Additionally, by Order No. 16804, IXCs are prohibited from constructing facilities to bypass a local exchange company without express prior approval from the Commission.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the application of Triax Telecom, Inc. for a certificate to provide intrastate interexchange telecommunications service is granted as set forth in the body of this order. It is further
