SOUTHERN BELL TELEPHONE AND TELEGRAPH COMPANY'S NOTICE
OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

COMES NOW BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and pursuant to Rule 25.22.006, Florida Administrative Code, files its Notice of Intent to Request Confidential Classification.

1. The Staff of the Florida Public Service Commission ("Staff") has issued several Audit Requests in connection with the NARUC/FCC Regional Audit of BellSouth. Staff has requested, among other things, that Southern Bell furnish the following information:

- H - Field trial evaluation and recommendation reports by S&C organization. Final or latest reports, if not closed, are requested."

3. Some of the information being provided is clearly proprietary. For example, the information being provided contains detailed strategic planning information, financial and cost information relating to unregulated affiliate companies, billings between nonregulated affiliates, and vendor-specific pricing information. Such information is specifically considered to be proprietary, confidential business information pursuant to § 364.183, Florida Statutes.


