SOUTHERN STATES' MOTION TO STRIKE COVA'S SUPPLEMENTAL MOTION FOR RECONSIDERATION

Southern States Utilities, Inc. ("Southern States"), pursuant to Rule 25-22.037, Florida Administrative Code, hereby moves the Florida Public Service Commission ("Commission") to Strike COVA's Supplemental Motion for Reconsideration. In support of this Motion, Southern States states as follows:

- On June 8, 1993, Cypress and Oaks Villages Association,
 Inc. ("COVA") filed its Supplemental Motion for Reconsideration
 ("Motion").
- 2. Rule 25-22.060(3), Florida Administrative Code, provides that motions for reconsideration "shall be filed within fifteen (15) days after issuance of the [final] order." The final order in this matter, Order No. PSC-93-0423-FOF-WS, was issued March 22, 1993. Rule 25-22.060 does not provide any authority for "supplemental" motions for reconsideration. Thus, as a matter of law, COVA's motion is untimely and without authority. Thus it should be stricken.
- 3. With respect to the substance of COVA's Motion, COVA has not cited any legal authority that would support its request for a new review and recommendation by a disinterested staff attorney.
