- On February 22, 1993, JEA submitted a Plan to Eliminate Duplicative Electric
  Facilities within the corporate boundaries of Jacksonville. The plan stated that JEA would
  present an offer to purchase OREMC's customers and equipment.
- While purchase proposals have been tendered which JEA believes to be fair and reasonable, OREMC and JEA have yet to reach an agreement.
- JEA wishes to continue negotiations for a reasonable period before exercising its eminent domain option.
