SOUTHERN BELL TELEPHONE AND TELEGRAPH COMPANY'S NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

COMES NOW, BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and pursuant to Rule 25.22.006, Florida Administrative Code, files its Notice of Intent to Request Confidential Classification.

The Staff of the Florida Public Service Commission 1. ("Staff") has issued several Audit Requests in connection with the NARUC/FCC Regional Audit of BellSouth. Staff has requested, among other things, that Southern Bell furnish the following information:

2. Audit Request No. 2-155, dated September 22, 1993 -"Provide the total charged to BST from each affiliate for return on investment as part of their FCC calculation for 1992. Include rate charged. Also include a breakdown of the total billed from these affiliates by BST cost pool and amount.

Provide same information if the affiliate bills other affiliates. Include name of affiliate, rate and amount of ROI. Include source of amounts obtained from all of the above. For all affiliates billing at FDC, this amount should be on the bill.

Information should be presented in a format similar to the following:

Affiliate%ROIAmountTotalChargingBilledChargedROIChargedBillingstoAccount6124CP3Account7503CPGETC"

3. Some of the information being provided is clearly proprietary. For example, the information being provided contains financial information on non-regulated affiliates. Such information is specifically considered to be proprietary, confidential business information pursuant to § 364.183(3)(e), Florida Statutes.

4. Consequently, because this information contains proprietary information, Southern Bell is filing this Notice of Intent to Request Confidential Classification, pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Staff to review this information without delay. Both the original of this notice and the individual requests have been filed with the Division of Records and Reporting, and a copy has been served on the Division requesting the information. The written Staff Requests are attached hereto.
