**SOUTHERN BELL TELEPHONE AND TELEGRAPH COMPANY'S
NOTICE OF MODIFICATION TO
TRAFFIC STUDIES AND NOTICE OF INTENT**

COMES NOW BellSouth Telecommunications, Inc. d/b/a/ Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), pursuant to Rule 25-22.006, Florida Administrative Code, and files its Notice of Modification to Traffic Studies and Notice of Intent, and states in support thereof the following:

1. On January 6, 1993, the Florida Public Service Commission ("Commission") issued Order No. PSC-93-0029-PCO-TL, which required Southern Bell to file traffic studies. By Order No. PSC-93-0764-PCO-TL, issued May 20, 1993, the time for filing these studies was extended until June 7, 1993. On June 7, 1993 Southern Bell filed the required traffic studies and, at the same time, filed a request for specified confidential treatment of certain information contained in these studies.

2. Southern Bell recently discovered that some of the information provided to the Commission in these traffic studies is erroneous. Specifically, the amount of revenue per message for traffic between three routes¹ was calculated using the toll rate that would normally apply. These three routes, however,

were subject to an EOEAS plan at the time the studies were conducted. Therefore, the revenue should have been calculated by making an adjustment for the effect of the EOEAS plan.

3. Southern Bell hereby gives notice that it is filing on this date a modification to the traffic studies to provide the correct revenue per message figures for these three routes.

4. The above-referenced information that is being filed today is proprietary, confidential business information that is protected from public disclosure by Section 364.183, Florida Statutes. Accordingly, Southern Bell hereby gives notice, pursuant to Rule 25-22.006, F.A.C., of its intent to seek confidential classification of this information.
