FOR AN EXTENSION OF WASTEWATER SERVICE AND FOR A LIMITED PROCEEDING DATED: January 7, 1994 NOTICE is hereby given that the Staff of the Florida Public Service Commission will conduct a customer meeting to discuss the application of North Fort Myers Utility, Inc. for an extension to its wastewater service area to include the Carriage Village and Royal Oaks Subdivisions, and a limited proceeding to conform the rates and charges to the residents of those subdivisions to those charged to all the other customers of North Fort Myers Utility, Inc. The meeting will be held at the following time and place: 7:00 P.M., Thursday, January 27, 1994 Carriage Village Clubhouse 5451 Bayshore Road North Fort Myers, Florida 33917 All persons who wish to testify are urged to be present at the beginning of the meeting, since the meeting may be adjourned early if no customers are present. Any person requiring some accommodation at this meeting because of a physical impairment should call the Division of Records and Reporting at (904) 488-8371 at least five calendar days prior to the meeting. PURPOSE The purpose of this meeting is to give customers and other interested persons an opportunity to offer sworn testimony regarding the applications and to ask questions and comment on the rates and charges as well as other issues. The present charge for wastewater service at Carriage Village is a flat rate of \$10.89 per month and at Royal Coach the flat rate is \$9.29 per month.

The rates North Fort Myers Utilities, Inc. applicable to you are as follows:

Base Facility Charge Gallonage Charge \$10.09

\$ 3.66 per 1000 gallons of water used (Maximum 10,000 gallons)

You will also be responsible for paying a one-time charge for service availability of \$740. North Fort Myers Utility, Inc. will allow you to pay this charge on an installment basis over 5 years at 10% interest, resulting in a monthly charge of \$15.72, or in a lump sum.

Staff members will answer questions to the extent possible. A representative from the utility has also been invited to respond to questions.

Any person who wishes to comment or provide information to Staff may do so at the meeting, orally or in writing. Written comments may also be sent to the Commission at the address given at the end of this notice.

PROCEDURES AFTER CUSTOMER MEETING

After the meeting, Staff will prepare and submit a recommendation to the Commission. The Commission will thereafter issue a proposed agency action order which may accept, reject or modify the Staff's recommendation. Five to ten customers or persons who attend the meeting and who wish to receive a copy of the recommendation and the order may so indicate at the meeting. Those individuals are expected to distribute the information in the recommendation and the order to other customers and interested persons. Anyone who is unable to attend and who wishes to obtain a copy of the recommendation or the order may do so by writing to the Commission at the address at the end of this notice.
