10. The necessity for a rate increase arises from the fact that as adjusted for the test year ending December 31, 1992, Petitioner will have a net loss in its water operations of (\$299,598). Petitioner proposes in this proceeding to increase its water operating revenues by \$428,201, which is sufficient to produce an 8.07% rate of return on its rate base.

The petition for a permanent increase in rates is based on the recovery of the utility's expenses necessary to provide safe, adequate and sufficient service, to meet operating and maintenance requirements mandated by this Commission and by the Department of Environmental Protection (and its predecessor, the Department of Environmental Regulation) in their respective compliance and consent orders, and to earn a fair return on the net plant in service and other assets used to serve the utility's customers, including the additions to plant mandated by the Commission and by the Department of Environmental Protection.

18. Petitioner seeks the approval of interim rates as provided by law, including but not limited to Section 367.082, Florida Statutes. The following data is provided in support of the Petition for interim rate increase:

- a. Adjusted Rate Base: \$364,970
- b. Adjusted Net Income Before Rate Increase: (\$86,407)
- c. Fair Rate of Return: 7.97%
- d. Required Total Interim Revenue: \$435,453
- e. Required Interim Increase in Revenue: \$120,935

19. The calculation of interim rate requirements is based on the historical test year ended December 31, 1992, without any proforma plant adjustments, but with an annualization of test year revenues and expenses and with a used and useful adjustment using the methodology included in Order No. 21122. The utility disagrees with the methodology and has used it only for determination of interim rates. The cost of capital for interim purposes is the actual cost of debt for the test year, based on a capital structure consistent with Order No. 21122. These adjustments are consistent with the provisions of 367.082, Florida Statutes.

WHEREFORE, Petitioner requests as follows:

1. That the Commission take jurisdiction over this Petition.

2. That the Commission allow Petitioner to place into effect, on an interim basis, the water rates shown on Exhibit "D"

which would produce additional operating revenues for water in the amount of \$120,935.

3. That the Commission allow Petitioner to place into effect, on a permanent basis, the water rates shown on Exhibit "C" which would produce operating revenues over its interim revenues in the additional amount of \$307,266.

4. That the Commission find that a fair and reasonable rate of return on Petitioner's rate base of \$1,029,277 is 8.07%, based on the test year ending December 31, 1992.

5. That the Commission grant to Petitioner a rate of return on equity of 9.07%, which is the maximum of the return of the current equity leverage formula, established by order of the Commission pursuant to Section 367.081(4), F.S.

6. That the Commission grant such other relief as may be appropriate.

The Customer must provide evidence that a structure is or will be present at the service location. The issues in the proceeding will be developed at the Prehearing Conference and a Prehearing Order will be issued by the Prehearing Officer. At the hearing, the applicant will present its case to the Commission, and the Commission will ultimately decide the disposition of applicant's request to increase its rates after hearing testimony and receiving evidence presented by all interested parties pursuant to the rules of the Commission.
