ORDER APPROVING TARIFF FILING

BY THE COMMISSION:

On December 1, 1993, GTE Florida, Inc. (GTEFL or the Company) filed a proposed tariff to add Star Information Plus (*SIP). *SIP would allow cellular company end-users requesting an intraLATA number from Directory Assistance to receive a mechanized announcement which would offer call completion to the requested number. The rate would be \$.35 per completed call. The Company also has requested Contract Service Arrangement (CSA) authority for its cellular directory assistance services, including *SIP.

Upon review, it appears that Star Information Service will provide added convenience which will benefit end users. It is a complementary product offering, is an expansion of Directory Assistance service, and it provides time savings to the end-user. *SIP may eliminate frustration for the existing end-users who are in a vehicle or other location where it is inconvenient to record and then dial the requested telephone number. Due to competitive pressures, we find that it is appropriate to grant the requested Contract Service Agreement authority. Therefore, we shall approve the tariff with an effective date of February 16, 1994. The Company shall include cellular directory assistance services in its guarterly CSA Activity report.

Therefore, it is

ORDERED by the Florida Public Service Commission that GTEFL's tariff filing to add Star Information Plus is hereby approved with an effective date of February 16, 1994. In addition to the tariffed rates, the Company shall be granted Contract Service Arrangement authority for its cellular directory assistance services, including *SIP. The Company shall include cellular directory assistance services in its quarterly CSA Activity report to this Commission. It is further

ORDERED that if a timely protest is filed, this tariff shall remain in effect with any increase held subject to refund pending resolution of the protest. If no timely protest is filed, this docket shall be closed.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

hearing or judicial review will be granted or result in the relief sought.

The Commission's decision on this tariff is interim in nature and will become final, unless a person whose substantial interests are affected by the action proposed files a petition for a formal provided Rule 25 - 22.036(4), Florida by proceeding, as provided Rule the form by Administrative Code, in 25-22.036(7)(a)(d) and (e), Florida Administrative Code. This petition must be received by the Director, Division of Records and Reporting at his office at 101 East Gaines Street, Tallahassee, Florida 32399-0870, by the close of business on March 28, 1994.

In the absence of such a petition, this order shall become final on the day subsequent to the above date.

Any objection or protest filed in this docket before the issuance date of this Order is considered abandoned unless it satisfies the foregoing conditions and is renewed within the specified protest period.

If this Order becomes final on the date described above, any party adversely affected may request judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or by the First District Court of Appeal in the case of a water or wastewater utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days of the date this Order becomes final, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
