ORDER INDICATING EXEMPT STATUS OF COZUMEL
ASSOCIATES AND CLOSING DOCKET

BY THE COMMISSION:

On February 11, 1994, Cozumel Associates (Cozumel) filed an application with this Commission for recognition of its exempt status, pursuant to Section 367.022(8), Florida Statutes. Cozumel is an existing apartment complex located at 3333 Monument Road, Jacksonville, Florida 32225. Ms. Jacqueline Coscia, the complex's president, filed the application on behalf of Cozumel. The primary contact person is Mr. Frank Manno, who is located at 90 South Newton Street Road, Suite #2, Newton Square, Pennsylvania 19073-4035.

Upon request and sufficient proof, the Commission will issue an order indicating the nonjurisdictional or exempt status of water or wastewater systems if they qualify under the appropriate provision of Chapter 367, Florida Statutes. The application was filed in accordance with Section 367.022(8), Florida Statutes, and Rules 25-30.060(2) and (3)(h), Florida Administrative Code.

Section 367.022(8), Florida Statutes, states, in part, that "[a]ny person who resells water or wastewater service at a rate or charge which does not exceed the actual purchase price thereof," and who complies with certain reporting requirements, is exempt from Commission regulation. According to Cozumel's application, service is provided at a charge that does not exceed the actual purchase price; Cozumel is aware of the requirements of Rule 25-30.111, Florida Administrative Code; Cozumel provides water and wastewater service; and the service area is limited to the apartment complex.

In addition, pursuant to Section 837.06, Florida Statutes, and Rule 25-30.060(2)(f), Florida Administrative Code, anyone knowingly making a false statement in writing with the intent to mislead is guilty of a misdemeanor. By signing the application, Ms. Coscia acknowledged that she is aware of Section 837.06, Florida Statutes, and the penalties for making false statements in the application.

Based on the facts as represented, we find that Cozumel is exempt from Commission regulation as a reseller pursuant to Section 367.022(8), Florida Statutes. In the event of any change of circumstances or method of operation, the owner of Cozumel or any successors in interest, must inform the Commission within 30 days of such change so its exempt status may be reevaluated.


It is, therefore,

ORDERED by the Florida Public Service Commission that, based upon the facts as represented, Cozumel Associates, 3333 Monument Road, Jacksonville, Florida 32225, is hereby exempt from Commission regulation pursuant to the provisions of Section 367.022(8), Florida Statutes. It is further

ORDERED that should there be any change in circumstances or method of operation, the owner of Cozumel or any successors in interest shall inform this Commission within 30 days of such a change so that we may reevaluate Cozumel's exempt status. It is further

ORDERED that Docket No. 940155-WS is hereby closed.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water or sewer utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Civil Procedure. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
