In the Motion, Staff requested that the utility's prefiled direct and rebuttal testimony be stricken. Staff's Motion for Sanctions was granted at the prehearing conference. Therefore, at the hearing, Staff will be given the opportunity to present testimony and other evidence on the issues identified by Staff at the prehearing conference. Shady Oaks failed to attend the prehearing conference. All witnesses shall be subject to cross-examination at the conclusion of their testimony.
