**GTE FLORIDA INCORPORATED'S NOTICE OF  
INTENT TO SEEK CONFIDENTIAL CLASSIFICATION**

Under Commission Rule 25-22.006(5)(c), GTE Florida Incorporated (GTEFL) gives notice of its intent to seek confidential classification of certain material in Mr. Joseph Gillan's late-filed Exhibit Number 1, "Cost Studies for General and United." This exhibit was submitted in response to a staff request during Mr. Gillan's August 9, 1994 deposition on behalf of the Interexchange Access Coalition (IAC).

This notice exempts this material from section 119.07(1) of the Florida Statutes and, therefore, protects it from public disclosure. GTEFL understands that IAC will today submit one copy of the highlighted, unredacted confidential information to the staff. The parties will receive only redacted copies.

The confidential information at issue concerns GTEFL's costs associated with its switched transport elements. The data presented in the Exhibit are derived from information provided to IAC by GTEFL under a strict protective agreement.<sup>1</sup>



This information falls within Florida Statutes section 364.183(3)(e), which defines proprietary confidential business information to include "information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of that information." Access services are competitive and will become even more so as a result of expanded interconnection. The data at issue would be valuable to potential competitors in formulating strategies to assure successful competition against GTEFL. This is an unfair competitive advantage which will distort the marketplace, to the ultimate detriment of the consumer.
