SOUTHERN BELL TELEPHONE AND TELEGRAPH COMPANY'S MOTION FOR EXTENSION OF DURATION OF ORDER GRANTING CONFIDENTIAL CLASSIFICATION Order No. PSC-93-0326-TL (Docket No. 920260-TL)

COMES NOW, BellSouth Telecommunications, Inc., d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company") and files, pursuant to Rule 25-22.006, Florida Administrative Code, its Motion for Extension of Duration of Order Granting Confidential Classification, and states as grounds in support thereof the following:

1. On September 14, 1992, Southern Bell filed a Request for Confidential Classification for information produced to Staff in response to Item Nos. 50 and 52 of Staff's Third Set of Interrogatories. The Commission assigned Document No. 10539-92 to this material.

2. By an Order issued March 3, 1993, the Florida Public DOCUMENT NUMPER-DATE

Service Commission ("Commission") granted Southern Bell's Request for Confidential Classification of information contained in this document. (Order No. PSC-93-0326-CFO-TL) Specifically, the Commission approved Southern Bell's request for confidential classification of unregulated itemized expenses, net income and forecasted revenues/expenses associated with one of Southern Bell's unregulated affiliates, BellSouth Advertising and Publishing Company ("BAPCO").

3. Under the provision of Rule 25-22.006 (8) (a), an order granting confidential classification is effective for 18 months. Therefore, the confidential classification granted in this Order expires on September 3, 1994. The Commission may, however, extend the period of confidentiality for good cause shown.

4. The information in question remains in the possession of the Staff.

5. The reasons Southern Bell asserted in support of confidential treatment in its original motion continue to pertain. Specifically, there is still a need to protect BAPCO's expenses, net income and forecasted revenues/expenses from disclosure.

6. For the reasons set forth above and in the original Request for Confidential Classification filed on September 14, 1992, Southern Bell hereby requests that this Commission enter an Order extending the period of confidential classification for an additional 18 months, or for any longer period of time that the documents remain within the possession of staff.

WHEREFORE, for the reasons set forth above, Southern Bell
