City Gas Company of Florida ("City Gas" or "the Company"), by and through its undersigned attorneys, submits this its Petition to the Commission for approval of a Purchased Gas Adjustment ("PGA") factor to be applied to customers' bills to be rendered during the period April 1, 1995 through March 31, 1996, and in support thereof, says:

1. City Gas has calculated its total net true-up amount (including interest and applicable regulatory assessment fees) for the period October 1993 through March 1994 to be an overrecovery of \$1,173,451.

2. Schedule E-4 shows the projected true-up for the current period April 1994 through March 1995 is an overrecovery of \$1,204,067. The total true-up as shown on Schedule E-4 is an overrecovery of \$30,616 (including interest of \$1679).

3. Schedule E-5 shows estimated therm purchases for resale of 90,978,917 for the period April 1995 through March 1996 producing a true-up factor of \$.00034 per therm.

4. After deducting the true-up refund factor, the maximum levelized purchased gas cost factor for April 1995 - March 1996 should be \$.38640 per therm (before the regulatory assessment fees) or \$.38785 after the regulatory assessment fees.

WHEREFORE, City Gas Company of Florida respectfully requests that the Commission enter its order approving the Company's proposed maximum levelized PGA true-up factor for the period April 1995 through March 1996 of \$.38640 per therm (before the regulatory assessment fees) or \$.38785 per therm after the regulatory assessment fees.
