PETITION OF MCCAW COMMUNICATIONS OF FLORIDA, INC. FOR DISPOSITION OF 1995 UNALLOCATED RATE REDUCTIONS

MCCAW COMMUNICATIONS OF FLORIDA, INC., on behalf of itself and its Florida regional affiliates ("McCaw"), pursuant to Order No. PSC-94-0172-FOF-TL, respectfully proposes to the Florida Public Service Commission ("Commission") that a portion of the \$25 million unallocated rate reduction scheduled to be implemented October 1, 1995 be utilized, if necessary, to implement the decisions rendered in Docket No. 940235-TL. In support of this request, McCaw states:

- 3. McCaw's intervention in this docket was authorized by Order No. PSC-92-1490-PCO-TL. McCaw is a signature party to the January 12, 1994 Implementation Agreement for Portions of the Unspecified Rate Reductions in Stipulation and Agreement Between the Office of Public Counsel and Southern Bell Telephone and Telegraph Company ("Implementation Agreement") approved by Order No. PSC-94-0172-FOF-TL.
- Pursuant to the terms of paragraph 4, of the 4. Implementation Agreement approved by the Commission in Order No. PSC-94-0172-FOF-TL, not less that 120 days prior to October 1, 1995 the parties must submit their proposals for the disposition of the \$25 million in unallocated rate reduction relief authorized by the Stipulation and Agreement Between the Office of Public Counsel and Southern Bell Telephone and Telegraph Company also approved by Order No. PSC-94-0172-FOF-TL. The current Case Assignment and Scheduling Record in this docket identifies May 15, 1995 as the date for parties to file proposals with the Commission. By the terms of the Implementation Agreement, McCaw is not precluded from submitting its proposals to the Commission.
- 5. McCaw proposes that <u>if necessary</u> a portion of the remaining \$25 million in unallocated 1995 rate reduction funds be

utilized to implement the Commission's decision in Docket No. 940235-TL. McCaw is making this filing out of an abundance of caution and to protect its interests. As of this date, the Commission has not rendered a final decision in Docket No. 940235-TL. Moreover, at this point the impact, if any, of the recently passed telecommunications bill (Senate Bill 1554) on the Docket No. 940235-TL proceedings has not yet been fully identified. Thus, McCaw is making this filing in order to preserve, if necessary, any rate reductions that may be ordered in Docket No. 940235-TL that may otherwise be barred by operation of the amended Chapter 364.

- 6. McCaw anticipates obtaining from Southern Bell information that would quantify the revenue impact of this proposal and provide additional necessary information. Accordingly, McCaw reserves the right to modify or supplement this proposal as appropriate.
- 7. At this time, the Commission has not yet issued a procedural order in this docket, but the Case Assignment and Scheduling Record ("CASR") identifies June 1, 1995 as the issues identification conference and June 15, 1995 as the filing date for direct testimony. Accordingly, McCaw is prepared to explain and support this proposal in subsequent authorized proceedings.

WHEREFORE, McCaw respectfully requests that, if necessary, the proposal for mobile interconnection usage reductions set forth herein be approved to be effective October 1, 1995.
