NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

COMES NOW BellSouth Telecommunications, Inc., ("BellSouth" or "Company"), and files pursuant to Rule 25-22.006(5)(c), Florida Administrative Code, its Seventh Notice of Intent to Request Confidential Classification ("Notice").

1. The hearing in the above-styled docket were held on August 22, 1994 through August 24, 1994. Pursuant to Commission Order PSC-95-0580-FOF-TP, issued June 6, 1995, BellSouth is filing its tariffs concerning the restructure of its switched access local transport services. In addition, BellSouth is filing, pursuant to the Commission's Order, tariffs that will put into place the structure for the application of zone pricing for switched transport. The Order required BellSouth to file cost support and contribution analyses for the tariff rates. This type of information is considered by BellSouth to be confidential proprietary business information and as such must be protected from disclosure. Disclosure would be harmful to the business interests of BellSouth. BellSouth will file, pursuant to Rule 25-22.005 and after 21 days, its request for confidential treatment of the proprietary information contained in the late filed exhibit.

2. Because the exhibit may contain exempt information, BellSouth is filing this Notice of Intent to Request Confidential
