CASE BACKGROUND

Section 364.337(3), Florida Statutes, (effective July 1, 1995) reads as follows:

(3) The commission shall grant a certificate of authority to provide intrastate interexchange telecommunications service upon a showing that the applicant has sufficient technical, financial, and managerial capability to provide such service in the geographic area proposed to be served.

STAFF DISCUSSION

ISSUE 1: Should the Commission grant GTE TELECOMMUNICATIONS SERVICES INCORPORATED (GTE) a certificate to provide statewide interexchange telecommunications service within the State of Florida as provided by Section 364.337 (3), Florida Statutes?

STAFF ANALYSIS: GTE originally filed an application with this Commission on November 29, 1994, to offer telecommunications services as a switchless rebiller. However, because of problems with their tariff and the additional information required with the passage of Chapter 364.337 (3), Florida Statutes, (effective July 1, 1995), GTE was not able to file all of the required information with this Commission until December, 1995.

GTE's exhibit of managerial qualifications reflects distinguished records in telecommunications sales, marketing and service. In regard to technical capability, GTE indicates that it will rely on the network ownership, operation and management of its underlying carrier(s)-currently MCI. GTE ensures a high reliability of call completion and prompt response to service problems including a customer troubleshooting service 24 hours a day, seven days a week. A review of GTE's financial capability shows that GTE has met the minimal financial requirements of the statute to provide and maintain the proposed telecommunication service. Further, since GTE is not requiring a deposit or an advance payment, there will be no customer provided funds at risk.

ISSUE 2: Should this docket be closed?

<u>RECOMMENDATION</u>: Yes, if no person whose substantial interests are affected by the Commission's Proposed Agency Action, files a protest within 21 days of the issuance date of the order.

<u>STAFF ANALYSIS:</u> This docket should be closed, if no person whose substantial interests are affected by the Commission's Proposed Agency Action, files a protest within 21 days of the issuance date of the order.

Section 364.337 (3), Florida Statutes, requires the following:

The commission shall grant a certificate of authority to provide intrastate interexchange telecommunications service upon a showing that the applicant has sufficient technical, financial, and managerial capability to provide such service in the geographic area proposed to be served.

Also Section 364.01 (3) and (4) states that:

(3) The Legislature finds that the competitive provision of telecommunications service, including local exchange telecommunications service, is in the public interest.

(4)(d) The Commission shall exercise its exclusive jurisduction in order to: (d) Promote competition by encouraging new entrants into telecommunications markets

Regarding the showing of financial capability, the Finance staff has analyzed the unaudited financial statements of GTE Telecommunication Services, Inc. (GTE-TSI). The company requested and was granted confidentiality for its financial statements. An audit could change one's opinion of the company's financial condition. Staff does not consider the financial ratios of GTE-TSI to be an impediment in obtaining a certificate.

GTE-TSI does not plan to offer debit cards. Staff notes the limited nature of the application and that no customer provided funds are at risk. Under the minimal requirements of the statute, the application appears adequate.
