ORDER INDICATING EXEMPT STATUS OF FANTELLI RV PARK AND CLOSING DOCKET

BY THE COMMISSION:

On February 7, 1996, Fantelli RV Park (Fantelli) filed an application with this Commission for recognition of its exempt status, pursuant to Section 367.022(4), Florida Statutes. Fantelli is a recreational vehicle park located at 3239 U.S. Highway 19 North, Inglis, Florida. Mr. Roy J. Fantelli, Owner and primary contact person, filed the application on behalf of Fantelli.

Upon request and sufficient proof, the Commission will issue an order indicating the nonjurisdictional or exempt status of water or wastewater systems if they qualify under the appropriate provision of Chapter 367, Florida Statutes. The application was filed in accordance with Section 367.022(4), Florida Statutes, and Rule 25-30.060(3)(d), Florida Administrative Code.

Section 367.022(4), Florida Statutes, states that public lodging establishments providing service solely in connection with service to their guests are exempt from Commission regulation. The application indicates that Fantelli provides service only to its guests and there is no separate charge for utility service. Wastewater service is provided by septic tank.

In addition, pursuant to Section 837.06, Florida Statutes, and Rule 25-30.060(2)(d), Florida Administrative Code, anyone knowingly making a false statement in writing with the intent to mislead is guilty of a misdemeanor. By signing the application, Mr. Fantelli acknowledged that he is aware of Section 837.06, Florida Statutes, and the penalties for making false statements in the application.

Based on the facts as represented, we find that Fantelli is exempt from our regulation pursuant to Section 367.022(4), Florida Statutes. However, the owner of Fantelli or any successors in interest are put on notice that if there is any change in circumstance or method of operation, it should inform the Commission within 30 days of such change so that its exempt status may be reevaluated.

It is, therefore,

ORDERED by the Florida Public Service Commission that, based upon the facts as represented, Fantelli RV Park, 3239 U.S. Highway 19 North, Inglis, Florida 34449, is exempt from Commission regulation, pursuant to the provisions of Section 367.022(4), Florida Statutes. It is further

ORDERED that this Docket is hereby closed.

This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
