RESOLUTION



A RESOLUTION OF THE JACKSON COUNTY, FLORIDA, BOARD OF COUNTY COMMISSIONERS REQUESTING THE FLORIDA PUBLIC SERVICE COMMISSION TO APPROVE AND ORDER EXTENDED AREA CALLING SERVICE BETWEEN ALL TELEPHONE EXCHANGES WITHIN JACKSON COUNTY.

RECITALS

WHEREAS, the Jackson County Board of County Commissioners represents the interests of all citizens of Jackson County; and

WHEREAS, Jackson County is a political subdivision of the State of Florida located in the northwest Florida, containing several rural and undeveloped areas;

WHEREAS, the Jackson County Board of County Commissioners believes that there is a more than normal degree of a shared community of interest, both personal and business, between all Jackson County citizens, they are all integral parts of Jackson County's economic, cultural, and civic community and all share the same Jackson County seat and Courthouse, located in Marianna.

WHEREAS, the existence of a regular long distance charge for telephone service between certain areas of Jackson County inhibits the integration and growth of Jackson County, and

WHEREAS, the expanded calling scope of Extended Area Calling Service would complement the needs of both business and residential interests in the expanding areas of Jackson County, which are increasingly interdependent by both the strands of commerce and personal relationships and, therefore, share the need for economical methods of communication between the various areas of Jackson County; and

WHEREAS, the Jackson County Board of County Commissioners believes that there is a sufficient desire by all of the telephone subscribers in Jackson County to warrant establishing Extended Area Calling Service or other toll-alternative arrangements between the above-referenced areas and exchanges within Jackson County;


NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners in Jackson County:

Section 1. That Jackson County requests the Florida Public Service Commission to approve and order the implementation of Extended Area Calling Service or other toll-alternative arrangement between all exchanges within the boundaries of Jackson County.


Section 2. The Clerk is directed to provide a copy of this Resolution to the Florida Public Service Commission.
